
Subject: State wise allocation under Sub-Mission on Agro-forestry (SMAF) for 2020-21 and Preparation of Annual Action Plan for implementation of Sub-Mission on Agro-forestry (SMAF) under the National Mission for Sustainable Agriculture (NMSA)-reg

Sir/Madam,

This is in reference to implementation of **Sub-Mission on Agro-forestry (SMAF) under the ambit of National Mission for Sustainable Agriculture (NMSA)**. The precondition for availing the benefit of the programme is to liberalise the transit rules for specified tree species. Annual allocation has been done for these states only. The pattern of assistance between Central and States is in ratio of 90:10 for North Eastern & Himalayan States and 60:40 for all other States. For UTs, the assistance will be 100% from GoI.

2 The Annual Allocation of funds to the States as Central Share for implementation of SMAF for the year 2020-21 has been enclosed at Annexure-I. It is requested that Annual Action Plan (AAP) for the year (2020-21) based on Central and the corresponding state share under SMAF may be prepared as per the Operational Guidelines for SMAF and after due approval in the state be submitted for further processing and release of fund. Release of funds would only be processed after receipt of UCs & detailed Progress Report (including soft copy, photographs/video, location of the nursery and plantation created during the year, training imparted and beneficiaries, number of the saplings/seedlings in the nurseries species wise) against the funds already released to the respective State during previous years. The spill over work of the previous year approved AAP must be included separately in the AAP of 2020-21.
