Subject: Monitoring of RAD scheme progress by the DBT Bharat Mission-regarding.

Sir,

This is regarding Rainfed Area Development(RAD) scheme being implemented in the country from 2014-15 as a component of National Mission for Sustainable Agriculture.

2. For effective implementation & monitoring of the RAD scheme and also to adhere the e-governance system, a dynamic Monitoring Information System(MIS) portal has been developed (www.nmsa.dac.gov.in) at DAC&FW. MIS is web based application to monitor various activities undertaken by implementing agency at various levels and facilitates automatic compilation of Cluster/ Village/ District/ State wise information.

3. The process of operating of MIS has been discussed in various review meetings and it is being used by the respective states for uploading the requisite information and periodic progress of RAD scheme during the years 2014-15, 2015-16, 2016-17, 2017-18 and 2018-19.

4. From April 2018, MIS for RAD has been on-boarded on DBT Bharat Mission(dbtbharat.gov.in). Now requisite information and periodic progress of RAD, uploaded by the State Governments on RAD MIS, is monitored every month by the DBT Bharat Mission. It is therefore requested that the State Governments may please upload the monthly progress for the FY 2018-19 on a regular basis. 
