Please refer to this Ministry's earlier immediate letter number 2-3/2017-RFS-III dated  $19^{th}$  June 2018 regarding the above mentioned subject.

- 2. It has been conveyed to the State Governments that the progress of the RAD scheme is monitored every month by the DBT Bharat Mission(dbtbharat.gov.in) from April, 2018 onwards . For updating the monthly progress of the RAD scheme and also to adhere the e-governance system, a dynamic Monitoring Information System(MIS) portal has been developed (<a href="www.nmsa.dac.gov.in">www.nmsa.dac.gov.in</a>) at DAC&FW and is being used by the State Governments.
- 3. In this regard the State Governments have been requested to upload the RAD monthly progress for the FY 2018-19 on a regular basis. However, it has been observed that the uploading of RAD progress on the MIS by the implementing States is not satisfactory. The State Governments are, therefore, requested to regularly update the progress on the MIS.
