Sir,

This is in reference to implementation of **Sub-Mission on Agro-forestry (SMAF) under the ambit of National Mission for Sustainable Agriculture (NMSA)**. The precondition for availing the benefit of the programme is to liberalise the transit rules for specified tree species. Annual allocation has been done for these states only. The pattern of assistance between Central and States has been kept same, i.e. in ratio of 90:10 for North Eastern & Himalayan States and 60:40 for all other States. For UTs, the assistance will be 100% from GoI.

2. The Annual Allocation of funds to the States as Central Share for implementation of SMAF for the year 2019-20 has been enclosed at Annexure-I. It is requested that Annual Action Plan (AAP) for the current year (2019-20) with the corresponding state share under SMAF may be prepared as per the Operational Guidelines of the programme. However, release of funds would only be processed after receipt of UCs & Progress Report against the funds already released to the respective State during previous years.
